**Festo, one of the world's leading manufacturers of automation technology, is fully integrating Eichenberger Gewinde AG from Burg in Switzerland as of April 1, 2026. In future, the Swiss company will operate under the name "Festo Gewindetriebe AG".**

The aim of the complete integration is to strengthen the strategic anchoring of expertise in ball screw drives and to expand the product range, particularly for electrical automation. "Festo's electric actuators already have Eichenberger's top-quality lead screws on board," emphasizes Dr. Wolfgang Sperling, Head of the Electric Automation business unit at Festo.

In future, global sales of screw drives will be handled via Festo's existing sales channels. For customers, the integration means simplified access to a broader product portfolio and global service. Eichenberger's logistics will be gradually integrated into Festo's global logistics centers. The Swiss site will concentrate on the development and manufacture of customer-specific screw drives. Hansruedi Hager, previously Managing Director of Eichenberger Gewinde AG, will remain Managing Director of Festo Gewindetriebe AG after the integration and change of name.
